## Antique Vendor Terms and Conditions of Show

1. All items offered for sale shall be genuine antiques and/or vintage collectibles and shall be guaranteed as represented. No crafts, no new items or reproductions. All items must be marked. The hosts reserve the right to make all final decisions concerning the standards of the Exhibitor. Exhibitors shall be open for business during all show hours.
2. New York State law requires that each exhibitor have a valid sales tax certificate. You must submit a copy with this application. You are to have your original certificate displayed at all times during the show.
3. All exhibitors will be featured inside of the Sanborn Fire Company located at 5811 Buffalo Street, Sanborn. Exhibitors must set up their booths in a professional manner. All tables must have linen coverings draped to the floor, preferably a dark color. All containers and boxes must remain under exhibit tables. No plastic shelving allowed.
4. Neither The Niagara River Region Chamber of Commerce or any other agent thereof shall be held liable for any property lost, stolen or damaged during the show or to any personal injury to any exhibitor, its agents or employees during the show. Each exhibitor shall accept full responsibility and releases the above so named from all liability and any losses, damages, or injuries which may occur during the show.
5. No exhibitor shall break down its booth or leave the show prior to 5 pm. Exhibitors must clean their booth space at the end of the show. Any damages to premises, tables, or chairs must be paid for by the exhibitor.
9. Booth size is 10 x 10 and locations will be assigned on first received basis. Complete booth rental fee is due with application. Show is on rain or shine. **YOU ARE PROHIBITED FROM NAILING TAPING OR HANGING ANYTHING ON THE WALLS OF THE FIREHALL.**
10. **For a guaranteed spot, applications are due no later than August 23, 2010.** Upon receipt of your application, a confirmation letter and site assignment will be mailed to you. **Payment is due by September 1, 2010.**
11. **Cancellations must be made by August 30, 2010.** No refunds will be issued for cancellations made after that date.

**There will be no electrical supply for vendors.**
